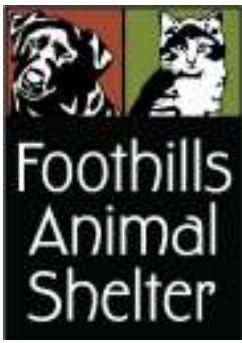

DOG TRAINING CLASS POLICIES

1. Handlers must clean up after their own dogs and dispose of waste in the proper containers.
2. Dogs must be supervised by their handlers at all times.
3. Children must be supervised and accompanied by a parent or guardian at all times.
4. Dog handlers must be a minimum of 16 years old.
5. Failure to supervise dogs, unsafe conduct, unsafe handling of dogs or improper use of equipment or property may result in dismissal from class without a refund.
6. Dogs exhibiting aggressive behaviors toward dogs or people, as determined by the instructor, may be asked to leave class.
7. Female dogs in season (in heat) or dogs that are sick are not allowed to participate in classes or be on the premises.
8. Choke, prong, and electric (static) collars are not permissible training devices for use in class.
9. There will be a \$25 fee for any returned check. More than one occurrence could result in the requirement of cash for all payments.
10. There is a three person minimum enrollment for all classes. The instructor, Stephanie Baigent, reserves the right to cancel a session if enrollment does not meet this minimum.
11. Dogs are not permitted to interact with each other during class unless permission to do so has been given by the instructor. Owners shall maintain a distance of at least a leash length between their dog and all other dogs in class.
12. In case of inclement weather, owners will be notified of class cancellations. Classes cancelled on account of the weather will be rescheduled.
13. Dogs and puppies must be up to date on vaccinations. All puppies need to have completed all three series of Distemper/Parvo vaccinations. All dogs and puppies need to be current on a Rabies, Distemper/Parvo and Bordetella vaccinations. **Proof of vaccination is required. Please fax (303.278.8552) or mail (580 McIntyre St., Golden, 80401) vaccination records, Attn: Community and Event Coordinator, at the time of registration.**



Waiver of Liability and Informed Consent Release

I, the undersigned, certify that I am at least 18 years of age, and I have chosen to involve myself, others and/or my dog in dog training classes, private consultations, workshops or other related activities (the "Classes") offered by Foothills Animal Shelter.

By signing hereunder, I certify that I have been informed of and understand that participation in the Classes involves the risk of injury to myself, my family members, third parties and/or my dog arising out of circumstances that include, but are not limited to, the following: (i) there is always an unavoidable risk of injury involved when working with any animal, especially an animal that may have behavioral issues; (ii) all dogs can be inherently difficult to control; (iii) during participation in the Classes, all dogs will not be under control at all times; and (iv) other persons involved in the Classes may be distracted by the dogs or other activities. I confirm that I have had a full opportunity to discuss any and all concerns I may have about the foregoing risks with Foothills Animal Shelter and its authorized representatives. I have also made all inquiries and investigations to my satisfaction related to such risks, including, but not limited to, an examination of the training area (if applicable).

I hereby accept and assume, without reservation, any and all risks associated with participation in the Classes, including, but not limited to, any risks of injury to myself, my dog and any of my family members or third parties; the risks that my dog may cause injury to other persons and/or dogs involved in the Classes; and the risks that saliva, water, food, snow and/or other debris may be present in the training area. In addition, I have read and understand Foothills Animal Shelter's Training Facility Operating Policies, and agree to abide by them to the extent applicable.

As lawful consideration for participation in the Classes, I, on behalf of myself, my family members, heirs, executors, administrators, legal representatives, successors and assigns (the "Releasing Party"), hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless Foothills Animal Shelter and its members, managers, agents, employees, and all other person involved in the Classes (the "Released Parties") from any and all injuries, losses, claims and damages to any person or persons of any nature whatsoever, including claims arising from the Released Parties' own negligence, and all costs associated therewith, including attorneys' fees, court costs and consultant fees, arising in any way from participation in the Classes.

This Waiver of Liability and Informed Consent Release shall be legally binding on the Releasing Party. In the event the Releasing Party asserts any claim contrary to the contents of this Waiver of Liability and Informed Consent Release, the Releasing Party shall be liable for all expenses (including attorneys' fees, court costs and consultant fees) incurred by both the Releasing Party and the Released Parties. No waiver or modification of any provision herein shall be valid unless expressly agreed to in writing by both the Released Parties and the Releasing Party.

I hereby consent and agree that myself, my family members or my dog participating in the Classes are subject to photographs and/or audiovisual recording (the "Images"), and I authorize Foothills Animal Shelter to use and exhibit the Images as still photographs, transparencies, motion pictures, television, video or other similar media. I hereby release Foothills Animal Shelter from any and all claims for damages or liability for libel, slander, invasion of privacy or any other claim based on use of the Images.

Every provision herein is intended to be severable. If any one or more of the provisions herein is found to be unenforceable or invalid, that shall not affect the other terms and provisions hereof, which shall remain binding and enforceable. The undersigned agrees that the exclusive jurisdiction for any dispute arising out of the Classes shall the courts of Jefferson County, Colorado, and Colorado law shall apply to any such dispute.
